Research: Supervision

- We know that quality supervision of BHT staff is important for clinical efficacy
 - Supportive supervision also reduces burnout and increases employee engagement
 - Supportive supervision also increases career progression and longevity
- We know that quality supervision increases client and family progress in treatment
 - Experience and qualifications of supervisor plays a more important role in client progress than does number of treatment hours

Role of the Supervisor: Case Supervision

- Case supervision is the group of responsibilities for the supervisor relating to the client, their family, and their individualized treatment program
- Case supervision must take a holistic, "big picture" view of the program
- Case supervision also means the supervisor should know the program down to the details
- Case supervision requires ongoing assessment

Vineland-3: Ongoing Assessment of Adaptive Functioning

- The Vineland-3 Comprehensive form is normed for ages birth through 90
- The Comprehensive Report can be administered by Interview by qualified practitioners (High Level Supervisor) or via Comprehensive Parent/Caregiver Form- which is a self report form that the caregivers are able to complete on their own
- Both Interview and Parent/Caregiver forms are available in paper packet or electronically via Q-Global
- If administered via paper version, electronic scoring is available by manual entry into Q-Global
- TheBHPN is requiring providers to administer the Comprehensive version of the Vineland-3, (as opposed to domain level), due to its increased clinical relevance across all domains which leads to better longitudinal progress tracking.
- Providers should report on the v-scale scores, Maladaptive Behavior Index (MBI) and Critical Items.
- Motor Skills Domain are not required

Role of the Supervisor: Staff Supervision

- Staff supervision involves training, observations/overlaps, and productive, supportive feedback
- Staff support should be individualized to that person's skills and learning style
- Staff supervision should lead to increased exposure to learning opportunities

Role of the Supervisor: Caregiver Education

- Caregiver education and consultation is the most important part of program supervision
- Caregivers who are engaged in their child's treatment will have reduced stress and will build momentum in progress
- Caregiver education should be approached by the supervisor with empathy and humility

Supervision in the Next Normal: Telehealth Considerations

Telehealth: Supervision Benefits

- Supervisors can manage more programs (no drive time, etc.)
- Supervisors can overlap more staff more often
- Supervisors can work with caregivers more flexibly
- Supervisors can make treatment plan modifications in real time

Supervision via Telehealth: Recommendations

- Have a session schedule for your staff / caregiver
- Quickly check in with staff prior to their session (in-person or telehealth) to solidify plan for session
- Have specific goals / programs you want to observe prior to joining session
- Have a plan B,C, D...
- Always follow up afterward staff, caregivers, client
- Be Flexible!

Supervision via Telehealth: Cautions

- Check your rigidity things may not go as planned
- Manage employee-relations concerns offline, not during a telehealth overlap
- Materials may have to be modified (family does not have a printer, etc.)
- Take time to make a personal connection with client and caregivers, telehealth can feel impersonal
- Keep in mind screen time for clients and caregivers
- Practice self-care!
